

Safeguarding Policy



This policy applies to all members, volunteers or anyone working on behalf of Stape Silver Band

The purpose of this policy:

- To protect from harm, children, young people and adults who receive Stape Silver Band's services.
- To provide staff and volunteers, as well as children and their families, with the overarching principles that guide our approach to child protection.

Stape Silver Band believes that a child, young person or adult with care and support needs should never experience abuse of any kind. We have a responsibility to promote the welfare of all children, young people and adults at risk and to keep them safe. We are committed to practice in a way that protects them.

Legal framework

This policy has been drawn up based on law and guidance that seeks to protect children and adults at risk, namely:

We believe that:

- The welfare of the child is paramount, as enshrined in the Children Act (1989).
- All children, regardless of age, disability, gender, racial heritage, religious belief, sexual orientation or identity, have a right to equal protection from all types of harm or abuse.
- Some children are additionally vulnerable because of the impact of previous experiences, their level of dependency, communication needs or other issues.
- Working in partnership with children, young people, their parents, carers and other agencies is essential in promoting young people's welfare.
- In addition, we are aware that we also have safeguarding responsibilities towards adult members, some of whom may be vulnerable at different times in their lives. The principles outlined above in relation to children also apply to our work with adults. In terms of a legal framework, the arrangements for those over 18 are governed by the Care Act 2014.

Safeguarding Policy



- This Act stipulates that statutory safeguarding duties apply to an adult who has care and support needs, and is experiencing, or at risk of, abuse or neglect, and, because of those care and support needs, is unable to protect themselves from either the risk of, or the experience of, abuse or neglect.

We will seek to keep children, young people and adults safe by:

- Valuing them, listening to and respecting them, ensuring that, in the case of adults, we work with their consent unless 'vital interests' [as defined in the Data Protection Act (1998)] are at stake, or the person has been assessed as lacking mental capacity [as defined in the Mental Capacity Act (2005)].
- Adopting child protection and adult safeguarding practices through procedures and a code of conduct for members and volunteers.
- Providing effective support and training for volunteers with responsibility for children or vulnerable adults.
- Recruiting staff and volunteers safely, ensuring all necessary checks are made. All volunteers working with children will be DBS checked before starting to volunteer and the DBS's will be checked regularly.
- Sharing information about child protection and adult safeguarding with children, parents, volunteers and members.
- Sharing concerns with agencies who need to know and involving parents and children appropriately.
